

Terms and Conditions – Jamaica

JN Money Christmas 2 Sweet Promotion

1. Promotion Description

Residents who send or receive funds through JN Money will be automatically entered to be one of two weekly winners of cash during the promotional period of November 18, 2024, to December 27, 2024, in the Christmas 2 Sweet Promotion.

This promotion will give JN Money senders and recipients in Jamaica, the chance to be awarded cash. There will be two (2) weekly winners of up to JMD \$10,000 each in cash for each week of the promotional period.

2. Eligibility for Entry

Customers who have sent or received a transaction between November 18, 2024, and December 27, 2024, will be eligible for entry into the promotion. Each transaction sent and received gives the customer an automatic entry into the promotion. A selected winner is not eligible to win more than once in this promotion.

This giveaway is open to legal residents of Jamaica.

Participants must be 18 years of age or older as of November 18, 2024, and must have sent or received a qualifying transaction during the period.

The Sponsor reserves the right, to terminate this promotion in the event of any act of nature, occurrence, or reason that it believes would corrupt the integrity, administration, of fairness of the promotion subject to the approval of The Betting Gaming and Lotteries Commission.

3. Privacy

Information submitted by participants for the promotion may be disclosed by the Sponsor to third parties, pursuant to legal requirements.

Weekly Prize Details

A total of twelve (12) winners will be randomly selected to win a share of JMD \$120,000 i.e., two (2) winners each week receiving cash of up to JMD \$10,000 inclusive of transaction fees throughout the promotional period. Prizes will be paid to the winners' JN Money Card. The transaction selected for the prize draw will determine the cash prize value awarded to the selected winners. *For example: A winner who sent or received a transaction of \$5,000 during the promotional period, will be rewarded \$5,000 **OR** A winner who sent or received a transaction of \$15,000 during the promotional period, will be rewarded \$10,000 (the maximum cash prize per selected weekly winner).*

4. General Rules

- Employees and their immediate family members (parents, siblings, spouse, and children) of JN Money Services Limited, parent companies, affiliates, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

- **Claiming Period:** Winners will be notified by 12:00 p.m. on the day after selection. Failure to claim the prize within seven (7) days of notification (which does not include weekends) will result in its forfeiture resulting in an alternate entrant from the remaining eligible entries being selected. JN Money Services Ltd. reserves the right to retain all unclaimed prizes if entrants fail to claim their prizes within the specified period.
- The Sponsor reserves the right to delay, terminate or amend this promotion at any time, subject to any act of nature, occurrence, or reason that it believes would corrupt the integrity, administration, or fairness of the giveaway subject to the approval of The Betting, Gaming and Lotteries Commission. In any of these events, notice will be given to the participants via advertisement.
- The Sponsor reserves the right to use photographs or videos of winners in promotional articles and publicity features. If the winners refuse, they will forfeit the prize.

5. Eligibility for prize drawings will be determined by the following:

- 5.1 Automatic entries dated from November 18, 2024 – December 27, 2024.
- 5.2 Transactions not cancelled.

6. Selection for the prize winner will be governed by the following:

A representative from the JN Group Internal Audit Department will be invited to oversee the drawing on the dates outline under Section 10 “Date of Selection”.

7. All participants must agree to abide by the rules of the Promotion. The decision of JN Money Services Limited regarding all aspects of the Promotion will be final subject to the approval of The Betting, Gaming and Lotteries Commission or the relevant authorities.

8. Participants who do not adhere to the terms and conditions of the Promotion will be disqualified.

9. Method of selection of successful entrants:

There will be six (6) draw dates for the weekly prizes during the promotional period. A data pull will be requested from the JNMS Group Information Technology Unit detailing all qualifying entries.

Drawing for the two (2) successful entries will be selected on or about the dates under Item 10. An additional six (6) entrants for each draw will be chosen as back up successful entrants.

The successful participants will be notified by telephone. Three (3) consecutive telephone attempts will be made to reach each successful entrant on the day of the draw and no later than 12:00 p.m. of the following day. If JNMS has exhausted the number of attempts and calls were unsuccessful, the next person in line from the pre-selected back up entries will be selected.

A failed attempt is when the phone rings without an answer, goes to voicemail or is busy or answered by someone other than the person JNMS is trying to reach. Successful participants will be asked to produce a valid ID (Passport, National Identification Card or Driver's license). If entrants are unable to collect their prizes, someone else can do so on their behalf by producing a notarized authorization letter along with a valid identification of them self and the winner.
