

Terms and Conditions – Caribbean

Cash 4 School Promotion

1. Promotion Description

Residents who send funds through JN Money will be automatically entered to win cash prizes during the promotional period of August 9 to September 30, 2024, in the Cash 4 School Promotion.

This promotion will give JN Money senders in the Caribbean (Turks & Caicos and Antigua & Barbuda), the chance to be awarded cash prizes. There will be eight (8) winners of USD \$250 each during the promotional period.

2. Eligibility for Entry

This promotion is open only to residents of the Caribbean (Turks & Caicos and Antigua & Barbuda), who are 18 years of age or older at the time of entry. Employees and immediate family members of JN Money Services Limited, parent companies, affiliates, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

3. Prizes

This Promotion will give JN Money senders in the Caribbean region the chance to be awarded cash prizes. There will be four (4) monthly winners of USD \$250 for each month of the promotional period. As such, there will be a total of eight (8) winners at the end of the promotional period.

Prizes may not be transferred or assigned by the winner.

4. Eligibility for prize drawings will be determined by the following:

- Money transfer transactions conducted during the promotional period of August 9 to September 30, 2024.
- Transactions not cancelled.

5. Method of Selection of Participants

Entrants who send money transfers during the promotional period will be randomly selected as per schedule below:

Four entrants (potential winners) will be randomly selected, via a draw, at the end of the promotional period from among all qualified entries for the promotion. Eight additional entries (back-up potential winners) will also be selected from among all entries for the promotion in the event any of the potential winners do not qualify to be confirmed as a winner. To be confirmed as a winner of the Cash 4 School Promotion the following notification criteria must be satisfied:

- Telephone calls made in the order of they appear on the potential winner list.

- On the day of the draw, three (3) consecutive telephone calls will be attempted to reach a potential winner in keeping with the order the names appear on the potential winner list.
- A failed attempt is when the phone rings without an answer, goes to voicemail, is busy or answered by someone other than the person JN Money is attempting to reach.
- The four entrants who answer and identify themselves as the intended persons JN Money intends to reach will be selected as the winners.

The successful winners will be advised of the date and time to retrieve their prize. A replacement winner may be chosen if the previously chosen winner is unable to claim their prize within the time specified by JN Money.

6. Odds of Winning

The odds of winning depend on the number of entries received.

7. Conditions of Acceptance of Prize

Winners will be required to produce a valid Government Issued photo Identification document to claim their prize. Within one (1) day of prize notification, the winners will be required to send a written agreement (via email) to confirm that they will accept the prize, or the prize will be forfeited. The winners must visit the selected JN Money Branch on the designated date/time for the prize handover. If the winners fail to meet the conditions of claiming and accepting the prize, an alternative winner may be selected.

The winners will be solely responsible for all taxes, transportation costs, gratuities, and other incidental costs.

The winners agree to the use of his or her name and likeness in publicity without any additional compensation, except where prohibited by law.
