Terms and Conditions - Canada

Christmas 2 Sweet Promotion

1. Promotion Description

Residents who conduct transactions or Mail-In an Entry will be automatically entered to be one of two weekly winners of cashback during the promotional period of November 11 to December 27, 2024, in the Christmas 2 Sweet Promotion.

This promotion will give JN Money senders (Branches, Agents or Online) and mail-in entrants in Canada, the chance to be awarded cashback. There will be two (2) weekly winners of up to CAD \$200 each in cashback for each week of the promotional period. The lucky winners will be selected from a pool of mail-in-entries, branches, agent locations and JN Money Online.

2. Mail-In Entries

Two entrants (potential winners) will be randomly selected, via a draw, weekly from among all qualified entries for the promotion.
