

# Terms and Conditions – Cayman Christmas 2 Sweet Promotion

## 1. Promotion Description

Customers who send funds through JN Money Services (Cayman) Limited (JN Money) will automatically be entered to be one of two weekly winners of cashback during the promotional period of November 11 to December 27, 2024, in the Christmas 2 Sweet Promotion.

This promotion will give JN Money senders in the Cayman Islands the chance to be awarded cashback. There will be two (2) weekly winners of up to CI \$200 each in cashback for each week of the promotional period.

## 2. Eligibility for Entry

This promotion is open only to customers of the Cayman Islands, who are 18 years of age or older at the time of entry. Employees and immediate family members of JN Money Services (Cayman) Limited, parent companies, affiliates, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

## 3. Prizes

This Promotion will give JN Money senders in the Cayman Islands the chance to be awarded cashback. There will be fourteen (14) winners of up to CI \$200 each for the promotional period.

Prizes may not be transferred or assigned by the winner.

## 4. Eligibility for prize drawings will be determined by the following:

- Money transfer transactions conducted during the promotional period of November 11 to December 27, 2024.
- Transactions not cancelled.

## 5. Method of Selection of Participants

Entrants who send money transfers during the promotional period will be randomly selected as per schedule below:

Two entrants (potential winners) will be randomly selected, via a draw, weekly from among all qualified entries for the promotion. Six additional entries (back-up potential winners) will also be selected from among all entries for the promotion in the event any of the potential winners do not qualify to be confirmed as a winner. To be confirmed as a winner of the Christmas 2 Sweet Promotion the following notification criteria must be satisfied:

- Telephone calls made in the order they appear on the potential winner list.
- On the day of the draw, three (3) consecutive telephone calls will be attempted to reach a potential winner in keeping with the order the names appear on the potential winner list.
- A failed attempt is when the phone rings without an answer, goes to voicemail, is busy or answered by someone other than the person JN Money is attempting to reach.
- The two entrants who answer and identify themselves as the intended persons JN Money intends to reach will be selected as the winners.

The successful winners will be advised of the date and time to retrieve their prize. A replacement winner may be chosen if the previously chosen winner is unable to claim their prize within the time specified by JN Money.
